Thank you for your interest in participating in our First Time Home Buyer Savings Program. As a designated Community Development Financial Institution (CDFI), SWLACU focuses on providing financial education and fostering community partnerships that address education, housing, and transportation needs of our communities and our members. At Southwest Louisiana Credit Union our mission is Financial Empowerment for ALL, and we pride ourselves in assuring each day we live up to this mission.

About the Program

If chosen, you will participate in a series of classes that will assist you through the homeownership process while giving you real-world experiences to real-world solutions. Through this participation, you will be partnered with a financial counselor who will guide you through the process and create a plan to save \$1,000.00 for the home over a maximum period of 90 days. Upon completion, Southwest Louisiana Credit Union will match those saved funds 5:1 to create a total of \$6,000.00 to put towards your future home.

Key Requirements of the program:

- 1. Homeownership Preparation:
- Once a week for four weeks you must attend, The Homebuying Process classes. This class will include topics like, What Can I afford?, What is the homebuying process?, What are the costs and ongoing maintenance after I've become a homeowner?.
- 2. You must be purchasing in an EEG (eligible geographies) as identified by the U.S. Department of Treasury.
- 3. Financing must be completed through Southwest Louisiana Credit Union. (Members looking to buy a home more than 12+ months away, WILL NOT be eligible, nor will be considered for the grant)
 - No minimum credit score required.
 - Max Loan Term 30 Years
- Loan to Value Ratio 97%
- No PMI Required (Private Mortgage Insurance)
- ***Other Credit Conditions Will Apply***
- 4. Must save \$1,000.00 over the course of 90 days max to receive the match money of 5:1.
